

# Privacy Policy

Protecting your privacy is important to Meece Photography. We strive to keep your personal information confidential. By ensuring that you are aware of and understand the Meece Photography Customer Privacy Policy, we can provide you with better service. Please take a moment to read the following policy to learn how we handle your personal information.

## *Collection of Personal Information*

In order to give you superior customer service, Meece Photography collects your personal information in several ways. For example, Meece Photography may ask you to provide certain information such as your first and last name, mailing address (including zip code), e-mail address, telephone and facsimile numbers, and other personal information. When ordering products or services on the Site, you may be asked to provide a credit card number. Depending upon the activity, some of the information that we ask you to provide is identified as mandatory and some as voluntary. If you do not provide the mandatory data with respect to a particular activity, you will not be able to engage in that activity.

## *When you use the Site*

Meece Photography or third parties authorized by Meece Photography may also collect certain technical and routing information about your computer to facilitate your use of the Site and its services. For example, we may log environmental variables, such as browser type, operating system, CPU speed, and the Internet Protocol ("IP") address of your computer. We use these environmental variables to facilitate and track your use of the Site and its services. Meece Photography also uses such environmental variables to measure traffic patterns on the site. Without expressly informing you in each particular circumstance, we do not match such information with any of your personal information.

When you submit personal information to Meece Photography through this Site, you understand and agree that this information may be transferred across national boundaries and may be stored and processed in any of the countries in which Meece Photography and its affiliates and subsidiaries maintain offices, including without limitation, the United States. You also acknowledge that in certain countries or with respect to certain activities, the collection, transferring, storage and processing of your information may be undertaken by trusted vendors of Meece Photography. Such vendors are bound by contract to not use your personal information for their own purposes or provide it to any third parties. One instance where this could occur is in conjunction with framed pages in which the URL for the pages is not visible and the pages are being hosted by a vendor of Meece Photography. Meece Photography has established relationships with various service providers whose services are available to you from this Site or from web sites that are linked to this Site. Unless expressly provided to the contrary, personal information that you provide while you are visiting a provider's web site will be subject to the privacy policy posted on such site and personal information that you provide while on this Site in conjunction with a provider's service will be subject to this Privacy Policy. In the situation where sites have an Meece Photography "look and feel," and you reasonably believe you are on an Meece Photography site, the site is collecting information in a solely intermediary capacity and does not use personal information for secondary purposes. In order to reduce errors in our database, authenticate our users and prevent abuse of our system we may on occasion supplement the personal information you submit to us with information from third party sources. For example, we may supplement your registration information with address information provided by the U.S. Postal Service to qualify your information and prevent errors in our database.

## *How Your Personal Information is Used*

Meece Photography uses your personal information for several purposes including:

- To ensure our Site is relevant to your needs.
- To deliver services, such as newsletters, events or photos, which you request or purchase.
- To help us create and publish content most relevant to you.
- To alert you to special offers and other new services from Meece Photography.
- To allow you access to limited-entry areas of our Site as appropriate.

Meece Photography works with other companies that help us provide Meece Photography products and services to you, and we may provide your personal information to these companies. For example, we give shipping companies this information so they can deliver your products efficiently. The information they receive is for shipping and delivery purposes only, and we require that the companies safeguard your personal information in accordance with Meece Photography's policies. Meece Photography may disclose your personal information if required to do so by law or legal process. We may also disclose information about you if we believe that disclosure is necessary to protect the personal safety of Meece Photography employees, users of Meece Photography products or services, or members of the public.

### ***How We Protect your Personal Information***

Meece Photography is committed to protecting the security of your personal information. We use a variety of security technologies and procedures to help protect your personal information from unauthorized access, use or disclosure. For example, the Meece Photography Shop uses industry-standard Secure Socket Layer (SSL) encryption on all web pages where personal information is required. To make purchases from the Meece Photography Shop, you must use an SSL-enabled browser such as Netscape Navigator 7.x, Safari 1.0 or Internet Explorer 5 – 6.x. This protects the confidentiality of your personal and credit card information while it is transmitted over the Internet. We urge you to take every precaution to protect your personal data when you are on the Internet. Change your passwords often, use a combination of letters and numbers, and make sure you use a secure browser. Meece Photography uses IP addresses to analyze trends, administer the site, track user's movement, and gather broad demographic information for aggregate use. IP addresses are not linked to personally identifiable information.

### ***Our Companywide Commitment to Privacy***

To make sure your personal information remains confidential, we communicate these privacy guidelines to every Meece Photography employee. In addition, Meece Photography participates in industry initiatives to preserve privacy rights on the Internet and in all aspects of electronic commerce. Meece Photography does not knowingly solicit personal information from children or send them requests for personal information. Meece Photography's website contains links to other sites. Meece Photography does not share your personal information with those websites and is not responsible for their privacy practices. We encourage you to learn about the privacy policies of those companies. The Meece Photography Customer Privacy Policy is subject to change at any time. We encourage you to review the privacy policy regularly for any changes.
